# Objectives and legal basis for the processing

We will process your personal data for the purpose of:

- preparation of a product offer in response to an inquiry (art. 6(1)(b) of the Regulation<sup>1</sup>),
- sending marketing information by means of electronic communication and automation software on the basis of the Act of 18 July 2002 on the provision of services by electronic means and in connection with art. 172(1) of the Telecommunication Law of 16 July 2004 (alternative consent) on the basis of your consent (art. 6(1)(a) of the Regulation).

## Data storage period

Your personal data will be stored for the period necessary to prepare and submit a product offer until your withdrawal of the consent to receive marketing information.

## **Recipients of personal data**

In accordance with applicable laws on personal data protection, your personal data:

- may be transferred to providers of IT (maintenance and changes), marketing, and financial and accounting services. Such entities process data on the basis of a contract concluded with us and only according to our instructions,
- may be transferred to entities that are lawfully entitled to receive them.

## Your rights related to the processing of personal data

You have the following rights related to the processing of personal data:

- the right to access and correct your personal data,
- the right to transfer your personal data,
- the right to request deletion of your personal data, based on the conditions set out in art. 17 of

#### **Right of complaint**

#### Requirement to provide personal data
